All Memberships listed below are non-corporate, Individual/Family Memberships. Specific category is defined by age of the eldest spouse. Unmarried dependent children through age 22 are entitled to privileges of the Club.

Initiation fee is a one-time, non-refundable fee charged at the inception of membership.

Taxes are in addition to the price listed below. Initiation fees & dues are subject to change without notice.

Golf

Privileges include unlimited green fees, full access to both driving ranges, complimentary range balls, complimentary club storage, unlimited access to the Tennis Facilities, the Clubhouse, the Pool and the Fitness Facility.

Tennis

Privileges include unlimited access to the Tennis Facilities, the Clubhouse, the Pool and the Fitness Facility. Also included is the ability to play golf and pay applicable guest fees up to 6 times per year. **Youth Tennis Membership privileges include unlimited Tennis access only.*

Privileges include unlimited Clubhouse, Fitness Center & Pool access along with the ability to play golf & tennis and pay applicable guest fees up to 6 times per year.

Food Minimum

In addition to the monthly dues, there is a food minimum of \$150 per quarter (excluding tax and gratuity). All food & beverage purchases, including alcohol, apply to the quarterly food minimum.

Out of Radius

Out of Radius memberships are available for those that do not own, rent or lease a residence within 60 miles of Pinnacle Country Club. Membership acceptance is based upon property search. Out of Radius members may not purchase a seasonal cart plan or trail fee. Membership acceptance is based upon a property search. Out of Radius memberships are internally audited each year and are revocable at the discretion of Pinnacle Country Club.
